Dear EDSO Members

EDSO Football Technical Committee, made the following decision:

**Draw Procedures for 2015 Football Qualification.**

- 19 men teams will participate in the 2014 Men Football Qualification.
- The host country, Germany elected not to enter the 2014 Football Qualification.

**Allocation of Men Groups**

- In accordance to the EDSO Football Rankings (See attached),
- First eight teams will be place in Pot 1 as seeded,

**Russia, Ukraine, Turkey. Ireland, Denmark, Great Britain, Greece and France**

- Remaining 11 teams will be place in Pot 2.

**Drawing Men Teams from Pot.**

1. The 19 teams will be divided into 5 groups of 2 teams and 3 groups of 3 teams (see attached, EDSO Football Grouping).
2. The host country, Germany is elected not to enter the 2014 Football Qualification as they are automatic qualify for the Final Competition 2015 in Hanover.

**Annexe to Technical Regulation**

1. All Group Stage matches MUST be play from 6th April 2014 until 26th July 2014,
2. Group Stage (2 teams) shall be play in that order  
A1 v A2,      A2 v A1,
3. Group Stage (3 teams) shall be play in that order  
A1 v A2,      A2 v A3,      A3 v A1
4. Top 2 teams from each Group of 3 teams after the outcome of the Qualification Stage shall be qualifying for the Final Competition in Hanover.
5. Top 1 team from each Group of 2 teams after the outcome of the Qualification Stage shall be qualifying for the Final Competition in Hanover.

6. All the losing teams from each Group shall be place in Play-off stage  
(between 6 September 2014 – 15 October 2014)
7. All matches MUST be completed by **26th July 2014**, to determine the losing teams for Play-off Stages.
8. All Play Off stages start on 6 September 2014 and MUST complete by **15 October 2014** and it is **ONE** match only.
9. Losing team with the higher ranking shall be elect to play at **HOME for Play-off Stages**
10. Play Off Stage shall be play in this order, depending on the Ranking (see 9.)  
**A2 v B3, C2 v D3, E2 v F3, G2 v H2**

Only 16 teams from Men and Women qualify for the Final Competition in Sofia, Bulgaria, please see EDSO Website for General Sports Regulation, XI Sports (Team)
