Agenda 7 - rules

The European Deaf Volleyball Championships would be conducted in accordance with the Rules and Regulations of the FIVB (version 2015/2016) and EDSO (Volleyball) Technical Regulations.

JVDB showed the attendees the area for the warming up which would be used in case of longer matches. Totally there were 10 balls (Mikasa MVA 200) in each hall.

Agenda 8 - Audiograms

CS made the attendees aware that it was strictly forbidden to enter the volleyball court while wearing the hearing aids! Also, the referees needed to take attention for this.

When a person with hearing aids within the restriction zone will be caught that person would be excluded for the remainder of the tournament and a €460,= fine must be paid.

Agenda 9 - Form 4/uniform

Some countries had not submitted their FORM 4 yet – the athletes' final list. This must happen at the end of this meeting, also the checking of the uniforms.

The FORM 4 may have a maximum of 14 names (12 players + 2 LIBEROS). Replacing a libero is not allowed during the tournament.

Agenda 10 - Questions/answers

During this meeting the attendees were informed that the TDs were reachable for questions about referees, match schedule, Technical Regulations, equipment and the OC for questions about hotel, transport and meals.

- During the EC he medical treatment for injuries was provided by the first aid
- The OC provided the last information about transport, training schedule and meals.
- After the closing ceremony the best setter, spiker, opposite, middle blocker, libero and the Most Value Player (MVP) would be awarded per each gender.

Agenda 1,2 - start

JVDB welcomed all attendees at this Technical meeting after the meeting with the OC. Roll call: The men's and women's teams from all countries were present.

Agenda 3 - Evaluation

At first, JVDB expresses its gratitude for the OC for the smooth progress of this EC! The live
reports were a big success and, also the quality of the sports hall, staff and referees at all matches
were good. The level of the teams has raised again, especially that of women compared with 4
years ago. He congratulated the countries with their good work involving their volleyball teams!

- He referred to the high number of yellow and red cards that were distributed. Until today there were six red cards – three of them were used for one team. They will be fined according to the list penalty fees.
- The way in which the ceremony would be performed before the final matches (1-2 and 3-4) is explained to the countries.
- Netherlands: Many thanks to the OC for solving their problems despite their stay in another accommodation
- Germany showed their disappointment about the slow actions of the floor sweepers.
- **Belgium** prefers the EC Volleyball in the month May instead of July.
- **Ukraine** is satisfied about the organization of the EC but they are wondering if the duration of the EC can be shorter.

Agenda 4 - Applications TD 2015-2019

With much regret JVDB must resign as EDSO TD Volleyball. The main reason is the lack of time to devote himself 100% to this position due his other work as a CEO for the Belgian Federation.

He was very pleased that Cathy had helped him the last year because he was not be able to carry out his. Therefore, many thanks to Cathy! JVDB experienced 5 ECs (two as a player, one as OC coordinator and two as TD EDSO) He had made many friends and contacts, this farewell hurts!

He has seen strong improvements in terms of playing level, but also the level of Organization have has increased sharply.

He will wait to resign his position until the new candidate comes. He wants to support the candidate and will provide him/her any information.

CS told the meeting that she is not sure if she wanted to stay as an assistant TD or will resign too. It depends on the new TD, because it is very important that a TD and an ATD are a good team. If the new TD wants another assistant for a better cooperation or she will have the opinion that she don't have a click with the new TD, then it will be better that she will leave EDSO.

Agenda 5 - Participation European countries World Championships 2016 Washington

The attendees received the flyers about the WC 2016 from USA.

Perhaps the quota will be the same as for Deaflympics (see the next agenda point), but it depends on the amount applications per region, but usually 6 European countries can join the World Championships .The countries will receive the Form 1 soon!

Agenda 7 - Candidates host countries for organization EC 2019

Two countries have shown their interests to host the EC Volleyball in 2019:

- Italy already had a city and OC in their picture and they would discuss this further with FSSI.
- Netherlands had some interest as an host, but must still discuss with their Federation. Finally, it
 appears that they would reject their plans.

Ukraine would like to organize the EC once but they are not be able to do this due to political reasons. Hopefully it will happen in the future.

The EC 2019 bid books must be submitted prior to the EDSO congress in 2016 in Armenia.

Agenda 8 - EC Youth Volleyball 2016 - Poland

At the EDSO Congress 2014 Poland has applied to host the 1st EC Youth Volleyball in August 2016, although JVDB warned them that there is already a WC Volleyball in July 2016. JVDB and CS are not available to lead the youth EC in August.

The following teams will have a youth team to register for this EC: Russia, Poland, Turkey, Germany (?) and Ukraine have enough youth athletes to compose teams. So, it will go on!

Turkey said that the Youth EC in August 2016 will raise problems because it is the start of the new school year for the athletes.

U21 or U23? Germany told that they are only be able to participate in the U23 EC. **Ukraine** recommended that it would be better that the maximum age of the athletes will be determined until 21 because of more possibilities to raise funds from the governments. Decision meeting: EC youth - <u>U21!</u> **Poland** finally decided to move the EC youth from August to May 2016! Poland will fix the correct date and then the preliminary registrations can be sent to the countries.

Agenda 9 - Presentation Deaf Volleyball Champions League (DVCL) Committee

A new **DVCL committee** was presented on this meeting, they will organise this event from now on. The Champions League is only for the champion teams from each country. The runner-up may participate if there are places available. A maximum of 12 teams per gender will be allowed. Countries that don't have a competition can take part on behalf of a volleyball club. Registrations happens via the National Federation. (see registration Form)

Five persons applied themselves to join this commission, they are:

Matthias Bork (GER)Andriy Laylo (UKR)PresidentVice-president

Tomas Prekop (HUN) Secretary-General + website

- Nico Claerman (BEL) Treasurer + responsible Deaf referees

- Loredana Bava (ITA) Responsible Media - Face book

On behalf of EDSO are both TDs JVDB and CS the counselors of them.

President Bork outlined briefly the purpose of DVCL under the auspices of EDSO. The DVCL will take place <u>every year</u> - that is the outcome of the votes during the second technical meeting in Pesaro (It) in December 2014. The regulations will be improved after a while (audiogram with ID, check players one club per year, etc.).

He thanked EDSO for permission and the seed capital.

JVDB is pleased with this new committee and the development, it is important that the Volleyball in Europe will also be stimulated by the clubs. The experience of the board members within DVCL can be useful for the functions inside EDSO in the future.

Agenda 10 - DVCL Brugge (Belgium) 25 - 28/11/2015

DVCL has already sent the first entries (Form 1) to the EDSO members - to be submitted before 31/08/2015.

The Belgian OC will send more information about the prices of hotel soon. The prices are lower than in Italy, because it is a sport and youth hostel (Prices Full Board).
