PROPOSITION

OF CONTEST FOR 9. EUROPEAN HANDBALL CHAMPIONSHIP
FOR THE DEAF, TAKING PLACE IN SERBIA-BELGRADE 01.-06.
SEPTEMBER OF 2008.

Clause 1.

This propositions will constitute the terms of the competition representations competing at the European handball championship for the deaf, rank of the representations, as well as the other responsibilities that effluent from the competition on the European handball championship for the deaf.

Clause 2.

At European handball championship for the deaf participate seven registrated representations of the next countries as follows: Romania, Turkey, Germany, Croatia, Hungary, Italy and Serbia, as a host of the championship.

The representations are grouped in the preliminary in two groups.

Clause 3.

Competition on European handball championship for the deaf is conducted at the single point system and timely stipulated schedule.

Clause 4.

All the games at European handball championship for the deaf are playing according to the international handball regulations, which are brought by IHF.

Clause 5.

Rank of the representations will be settled based on the amount of points, therewith the representation gets two points for wining, one point for equal, and for defeat zero points.

At playing matches in the groups (preliminary) it will be stipulated the ranking of representations based on the points won.

In the case that two or more representations win the same amount of points, the rank is constituing at the next :

- a) it will be taken the results of internecine matches of the interested representations, and the rank will be settled based on the points won, on that kind of mini chart
- b) in the case of the same amount of points won in the internecine matches, the representation that has a better goal balance, between received and given goals in the internecine matches.

- c) In the case that it cannot be defined the rank even after implementing the segments a) and b), it will be taken the goal balance of received and given goals in the whole group.

Clause 6.

Two first ranked representations from each group (preliminary) make the new group and compete for ranking from 1st to 4th place, and the rest of the ranked representations from each group are making the second group and competing for the ranking from the 5th to 7th place.

Representations are taking the points and the goal balance from the internecine matches in the groups (preliminary) and further playing matches with representations that didn't compete in their group.

Clause 7.

Schedule of the representations per groups and schedule of playing matches is the part of this propositions and the sameone is in the annex.

Clause 8.

In the case that one of representations doesn't come to European handball championship for the deafit will be defined the new competition system, so that all representations make one group and the games are playing at single point system.

Clause 9.

The final rank of the representations on the European handball championship for the deaf is determining in the same way as ranking in the groups, as it is declared by this propositions.

Clause 10.

The right for competing on the European handball championship for the deaf are having all players that have played earlier at the Olympic games and European handball championship for the deaf, as well as the new players. For the new players that have not compete in the European handball championship for the deaf submitting of the audiogram is obligatory at surveying the documentation (passports) by the competing committee.

Clause 11.

On the match that is already played, the representation has a right for appeal, especially trough the manager of the representation, who is enrolled in the protocol of the game.

Appeal announcement is providing right after the game has finished, and the proposal of that game three hours after the game is finished.

At providing the appeal, it is necessary to pay the fee in amount of 100 EUR. In the case of appeal being accepted the fee will be returned to the applicator, otherwise it stays as a gain of EDSO.

All eventually appeals will be solved by the committee assembled of the: president of the EDSO Mrs. Isabelle Malaurie, handball manager of the EDSO Mr. Mario Torcollini nad the director of the European handball championship for the deaf Mr. Ivan Alivojvodic.

Clause 12.

All eventually discipline fouls of the players, officials, coaches, regarding the provided disqualifications because of the hard fouls, disqualifications from the bench of the players and officials (but not the disqualifications 3 x 2 minutes), disqualification till the end, will be decided by Mr Mario Torcollini.

Clause 13.

All decisions regarding the appeals, as well as the decisions for made discipline fouls must have been provided before playing the matches at next day of the competition.

Clause 14.

Delegating the judges on the European handball championship for the deaf will declare Mr. Mario Torcollini and the director of the European handball championship for the deaf Mr. Ivan Alivojvodic, ex international handball judge, carrier of the sign EHF judges.

On the European handball championship for the deaf the international and union judges can arbitrate.
